**Terms/conditions:** \* Customer agrees that Liberty Oil is their sole heating oil supplier \* Minimum purchase is 500 gallons \* Delivery of gallons reserved under this agreement begin 11/1/2023 and end 4/30/2024 (or sooner if purchased gallons are delivered prior to 4/30/24) \* This contract is non-refundable \* Any credit balance remaining after 4/30/24 will be applied to future deliveries at the current market price \* Customer may transfer his or her gallons and contract to a new homeowner in the event the home is sold during the contract period \* Liberty Oil must receive a signed/completed enrollment form (with payment) for contract to be valid \* If the customer breaches this contract prior to deliveries being completed, the customer agrees to liquidate Liberty Oil's damages for the cost of acquiring the oil, plus any overhead in the amount of \$500.00 (this will be prorated based on the gallons already delivered) \*

**Force Majeure:** Liberty Oil is not responsible for events beyond its control or for Acts of God that prohibit Liberty from fulfilling this contract. Events beyond Liberty's control include Acts of God; interruption of wholesale supply to Liberty, failure of common carriers, terrorism, civil commotion, war, riots, labor unrest, failure of public utilities, and under any such circumstances, Liberty Oil may cancel this contract.
